The Chairman called the meeting to order at 10:30 A. M.

The Chairman asked that a Secretary Pro-tem be elected in the absence of Mr. Storm. On a motion by Mr. McNamara, seconded by Mr. Burns, Mr. W. A. Ashley was unanimously elected as Secretary Pro-tem.

On a motion by Mr. Johnson, seconded by Mr. Imhoff, the minutes of the 97th Meeting held June 17, 1957, were unanimously approved as written.

On a motion by Mr. McNamara, seconded by Mr. Imhoff, the 46 applications submitted by the Secretary, were unanimously approved as per attached listing. Of the 46 applications, the applications for Nicholas J. Burke and Antas Marcukaitis, were approved retro-active to July 1, 1957.

The Secretary read a report of Chicago Transit Authority bills totaling \$1,766.94, and miscellaneous bills totaling \$329.89. On a motion by Mr. Murray, seconded by Mr. Burns, the Committee unanimously approved these bills.

The question regarding the date of death of the late Elmer L. Vogel which was held in abeyance from the last meeting was discussed by Mr. Hastings. This matter will be again brought before the Committee in the event that Mr. Walter does not return the Retirement Contributions on July 25.
