On a motion by Mr. Meinardi, seconded by Mr. Hill, the minutes of the 216th Meeting held on May 15, 1967, were unanimously approved.

The announcement of deaths reported since the last meeting was made by the Secretary as per the attached listing.

The Secretary advised that thirty-five (35) applications for retirement were submitted to the office for presentation at this meeting. One application for John J. Carr, Badge No. 10516, was recommended to be approved retroactive to June 1, 1967, due to a change in the employe's date of birth. One application for Miss Lorraine Falk, of the Accounting Department for Total and Permanent Disability Retirement, was recommended by the Secretary to be held in abeyance without action at this meeting since to date there has been insufficient medical information furnished regarding
