RETIREMENT PLAN FOR CHICAGO TRANSIT AUTHORITY EMPLOYES

The 228th Meeting of the Retirement Allowance Committee was held May 20, 1968, in the Secretary's Office, Room 746, in the Merchandise Mart, and the following were in attendance:

The Chairman called the meeting to order at 10:30 A.M.

On a motion by Mr. Fitzsimons, seconded by Mr. Tiffy, the minutes of the 227th meeting held on April 15, 1968, were unanimously approved.

The announcement of deaths reported since the last meeting was made by the Secretary as per the attached listing.

The Secretary advised that thirty-two (32) applications for retirement were submitted to the office for presentation at this meeting. On a motion by Mr. Fitzsimons, seconded by Mr. O'Brien, the Committee unanimously approved the thirty-two (32) applications recommended by the Secretary.

The Secretary advised the Committee that Mr. Thomas J. Kelly, who is presently on Total and Permanent Disability Retirement, was examined by the Medical Department on May 1, 1968 and found physically able to perform duties for the Chicago Transit Authority. Mr. Kelly is currently working for another firm and does not desire to return to work for the Authority. Mr. Kelly made application for Early Retirement effective June 1, 1968. After general discussion by the Committee, it was agreed to approve the Early Retirement application for Mr. Kelly effective June 1, 1968 and to continue the Total and Permanent Disability Retirement Benefits until May 31, 1968. On a motion by Mr. Tiffy, seconded by Mr. Donnelly, the Committee unanimously approved this motion.

The Secretary reported that during the month, seven (7) employes on Total and Permanent Disability Retirement, as per the attached listing, were examined by the Medical Department or their records reviewed.

On a motion by Mr. Fitzsimons, seconded by Mr. O'Brien, the refunds numbering 53 and totaling \$104,973.98 to be made May 31, 1968, as per the attached report, were unanimously approved.

The Secretary read a report of the deposits, disbursements, and investments during the month of April as per the attached report.

The Secretary presented Chicago Transit Authority bills totaling \$6,687.84 and miscellaneous bills totaling \$10,880.98 for approval. On a motion by Mr. O'Brien, seconded by Mr. Donnelly, the Committee unanimously approved payment of these bills.
