The announcement of deaths reported since the last meeting was made by the Secretary as per the attached listing.

The Secretary advised that thirty-six (36) applications for retirement were submitted to the office for presentation at this meeting. On a motion by Mr. Tiffy, seconded by Mr. Keiser, the Committee unanimously approved the thirty-six (36) applications recommended by the Secretary. Of these applications, one application

for A. Hastings was retroactive to June 1, 1968 due to a change in birth date from 1903 to 1901. On a motion by Mr. Keiser, seconded by Mr. Kohler, the Committee unanimously approved the application retroactive to June 1, 1968.

The Secretary reported that during the month, five (5) employes on Total and Permanent Disability Retirement, as per the attached listing, were examined by the Medical Department or their records reviewed.

On a motion by Mr. Meinardi, seconded by Mr. Kohler, the refunds numbering 41 and totaling \$51,603.37 to be made June 30, 1968, as per the attached report, were unanimously approved.

The Secretary read a report of the deposits, disbursements, and investments during the month of May as per the attached report.

The Secretary advised the Committee that two employes on Total and Permanent Disability Retirement were returned to duty in June, 1968. Harry G. Lang, Disability No. D-1463, who retired on T&P February 1, 1968, returned to duty June 12, 1968. Vernon W. Keene, Disability No. D-1457, who retired on T&P January 1, 1968, returned to duty June 17, 1968.

There being no further business, on a motion by Mr. Meinardi, seconded by Mr. Keiser, the Committee unanimously agreed that the meeting be adjourned. The meeting was adjourned at 11:00 A.M.
