The announcements of deaths reported since the last meeting was made by the Secretary as per the attached listing.

The Secretary advised that twenty-nine (29) applications for retirement were submitted to the office for presentation at this meeting. On a motion by Mr. Flynn, seconded by Mr. Kohler, the Committee unanimously approved the twenty-nine (29) applications recommended by the Secretary.
