The Secretary reported that during the month, five (5) employes on Total and Permanent Disability were examined by the Medical Department or their records reviewed.

On a motion by Mr. Keiser, seconded by Mr. Kohler, the refunds numbering 89 and totaling \$177,164.72, to be made October 31, 1970, as per the attached report were unanimously approved.

The Secretary read a report of deposits, disbursements and investments during the month of September, as per the attached report.

The Secretary presented Chicago Transit Authority bills totaling \$4,062.63, and miscellaneous bills totaling \$18,002.11, for approval. On a motion by Mr. Murray, seconded by Mr. Donnelly, the Committee unanimously approved payment of these bills.

On a motion by Mr. Fitzsimons, seconded by Mr. Kohler, the Committee unanimously approved payment of the death benefit.

The Secretary advised the Committee of the current status relative to the forged retirement checks of Mr. S. O'Mahony, deceased. The Secretary advised that the investigation to determine the financial status of Mrs. O'Mahony was unsuccessful because, the Savings and Loan Institutions are unable to release any information without a signed Release from the account holder.

After considerable discussion by the Committee, on a motion by Mr. C. E. Keiser, seconded by Mr. D. J. McFadden, it was unanimously agreed that the Secretary advise the Trustee to institute proceedings to collect on the forged checks still covered by the Statute of Limitations.

The Secretary read a letter from the Trustee dated October 16, 1970, relative to a proposed increase in rates for administering the Fund effective January 1, 1971, as follows:
