RETIREMENT PLAN FOR CHICAGO TRANSIT AUTHORITY EMPLOYES

The 270th Meeting of the Retirement Allowance

Committee was held on November 15, 1971 in the Secretary's

Mr. G. A. Riley alternate for Mr. C. E. Keiser was present.

The Chairman called the meeting to order at 10:30 A.M.

On a motion by Mr. Loughran seconded by Mr. Meinardi

the Minutes of the 269th Meeting, held on October 18, 1971

were unanimously approved.

The announcement of deaths since the last meeting were made by the Secretary as per the attached listing.

The Secretary advised that four (4) employes submitted survivorship options for presentation at this meeting.

On a motion by Mr. Flynn seconded by Mr. Loughran the Committee unanimously approved the four (4) options submitted by the Secretary.

The Secretary advised that twenty-six (26) applications for retirement were submitted to this office for presentation at this meeting. On a motion by Mr. Keiser seconded by Mr. Flynn the Committee unanimously approved the twenty-six (26) applications submitted by the Secretary.

The Secretary reported that during the month six (6) employes on Total and Permanent Disability were examined by the Medical Department or their records reviewed.

On a motion by Mr. Meinardi seconded by Mr. Riley the refunds numbering fifty-one (51) and totaling \$92,156.86 to be made November 30, 1971 as per the attached statement were unanimously approved.

The Secretary read a report of the deposits, disbursements and investments during the month of October as per the attached statement.

The Secretary presented Chicago Transit Authority bills totaling \$5,920.66 and miscellaneous bills totaling \$41,294.05 for approval. On a motion by Mr. Loughran seconded by Mr. McFadden the Committee unanimously approved payment of these bills.

The Secretary reported that for the payment of November 30, 1971 death benefits numbering thirty-seven (37) and amounting to \$44,000.00 are submitted for approval. On a motion by Mr. Meinardi seconded by Mr. Flynn the Committee unanimously approved payment of the death benefits as per the attached listing.

The Secretary distributed to the Committee a copy of the proposed Rule 18, which outlines the criterion required to prove the requirement of good health as stipulated in Section 13.2 of the Retirement Plan for Chicago Transit Authority Employes. After considerable discussion the Secretary was advised to change "in the discretion" to "at the discretion" in the proposed Rule 18 and to contact the Actuary to obtain an explaination of the need for a waiting period.

The Secretary advised the Committee that he contacted Mr. Hastings to determine if the current wage freeze would have any effect on the change in the minimum retirement effective January 1, 1972 and the \$10.00 increase in retirement benefits effective July 1, 1972. Mr. Hastings advised that the present wage freeze does not prevent these increases in pension payments and it was unlikely that any future wage freeze would have any effect on these pension increases.

The Secretary advised the Committee that Mr. R. A. Mendyk, Retirement No. D-1642, who was placed on Total and Permanent Disability on February 1, 1971, returned to duty on November 9, 1971.

The Secretary advised the Committee that Mr. Ted J. Barger, Retirement No. D-1664, who was placed on Total and Permanent Disability On June 1, 1971, returned to duty on November 9, 1971.

The Secretary advised the Committee that the Metal Trades Council sent a letter to Mr. W. C. Platt dated November 8, 1971 listing five (5) items of the Retirement Plan for Chicago Transit Authority Employes that they wished to negotiate. The Secretary referred this letter to Mr. Hastings for a legal opinion, relative to this letter. The Secretary read Mr. Hasting's opinion to the Committee in which Mr. Hastings stated that negotiation of these items could only be submitted not more than 90 days and not less than 60 days before the termination of the present retirement agreement, pursuant to Section 23.2 of the Retirement Plan for Chicago Transit Authority Employes. The Secretary advised that the Metal Trades Council requested that they be furnished with a copy of Mr. Hasting's opinion relative to their letter to Mr. Platt dated November 8, 1971. After discussion by the Committee the Secretary was advised to forward a copy of Mr. Hasting's opinion to the Metal Trades Council.

There being no further regular business, on a motion by Mr. Loughran seconded by Mr. Meinardi, the Committee unanimously agreed to adjourn. The Meeting adjourned at 11:23 A.M.
