Neither Mr. T. J. Murray nor his alternate were present.

The Chairman called the Meeting to order at 10:40 A.M.

On a motion by Mr. Meinardi, seconded by Mr. Keiser, the Minutes of the 142nd Meeting held March 20, 1961, were unanimously approved as written.

The announcement of deaths reported since the last Meeting was made by the Secretary as per attached listing.

On a motion by Mr. Parilla, seconded by Mr. Meinardi, the twenty-nine (29) applications submitted by the Secretary were unanimously approved as per the attached listing.

The Secretary reported that during the month, eleven (11) employes on Total and Permanent Disability, as per the attached listing, were examined by the Medical Department, or their records reviewed. On a motion by Mr. Meinardi, seconded by Mr. Parilla, the refunds to be made April 30, 1961, as per attached report were unanimously approved.

The Secretary read a report of deposits, disbursements and investments during the month of March as per the attached report.

The Secretary read a report of Chicago Transit Authority bills totalling \$2,365.66 and miscellaneous bills amounting to \$55.17. On a motion by Mr. Keiser, seconded by Mr. Moran, the Committee unanimously approved these bills.

Mr. Hastings advised that it would be necessary to hold the matter of the Inheritance Tax Consent Form in abeyance until the next Meeting.

Mr. Hastings advised that he has been in contact with the Attorney for Mr. J. Cashman, ex-employe, who will probably sue the Retirement Committee.

The Secretary reported that investigation of all pensioners endorsing their Retirement Allowance Benefit Checks with an "X" mark endorsement, has been started. There are 106 pensioners at the present time who endorse their Checks by "X" mark endorsement.

The Secretary advised the Committee that at the present time there are four Labor Unions that have not executed the Supplemental Agreement to Section 5 of the Retirement Plan effective December 31, 1960. After general discussion, it was agreed that the Secretary should write to these organ-
